Stepchild - Provide photocopy of the child's birth certificate or adoption order showing your spouse as the parent, as well as the marriage certificate. Nondependent stepchildren are not eligible for pass travel privileges unless the stepchild was a dependent of the employee prior to age 19.

Placement Order, Petition of Adopt, or Adoption Finalization Order.

Provide photocopy of the Adoption

Domestic Partner's child – Provide photocopy of the child's birth certificate showing domestic partner as the parent.

Children of domestic partner are not eligible for pass travel privileges unless the child was dependent of the employee prior to age 19. Note: Termination of domestic partnership will also terminate the pass travel privilege if the domestic partner's child.

Legal Guardian - Date you, the employee, were appointed Permanent Legal Guadian by the court:

Provide photocopy of the child's birth certificate, along with a copy of the Court order naming

you, the employee, as the Legal Guardian. Note: Custody is not acceptable.

Foster Child - Provide a photocopy of legal placement documentation showing the child has been placed in your

home as a foster child.

### 5 - Student or Military Criteria for Dependent/Non-Dependent Children

Child is a full-time college student – Must provide proof of current full-time student status at an accredited college or university, including attending a US Armed Forces Service Academy (US Military, Naval, Air Force, Coast Guard, or Merchant Marines Academy). \*\*Please include proof of fulltime enrollment from studentclearinghouse.org (enrollment verification)

Child is No Longer a full-time college student. Month/Day/Year last attended class:
